The Board of Directors has been working on formulating Policies \& Procedures for the operation of various aspects of the association. We decided to do this as a way of maintaining continuity over time, as offices and other volunteer positions are filled by different people. We have just finalized the first Policies \& Procedures document -- the one for UPBA Committees. It's just over 1 page long and it lays out all the essentials for managing a committee. We hope that this will make it easier for members to chair and serve on committees.

The last step in finalizing the P\&P for Committees was to review and discuss it at a Special Board Discussion to which all Committee Chairs were especially invited. Several members who are currently serving on UPBA committees had suggested a couple of months ago that the club might be able to get things done more efficiently if committee chairs had more direct contact with the full board. Board members agreed that this would be useful, and we are planning to have 4 extra Board meetings each year specifically for direct discussion with Committee Chairs. Other committee members and club members are also welcome to participate in these meetings. The agenda for each quarterly meeting will be posted in advance and any committee can have their topics included simply by giving them to either the Association Secretary or the board liaison for their committee a minimum of 15 days before the meeting. We held the first of these meetings on June 3rd and our main topic was, fittingly, the P\&P for Committees. The next Special Board Discussion with Committee Chairs will be in September. The exact date and time will be announced on the club e-mail list and on the
calendar at our yahoo site.
Other projects "in the works" are Policies and Procedures for hosting UPBA shows, managing the web site, and establishing and awarding trophies. We're also putting together a comprehensive annual calendar to ensure that we meet all UKC deadlines and avoid late fees and scheduling problems. At our next meeting we will begin preparations for the Annual Meeting in November.

Members who are interested in finding out more about the work the Board of Directors is doing for the club always have access to the minutes of Board meetings in the Files section of our yahoo site. There is some delay in posting these because, as required by our parliamentary authority, the minutes of every meeting have to be officially approved at the following meeting. Since the board meets every 3 weeks, there is always a 3week lag between a meeting taking place and the minutes of that meeting being posted. Anyone who wants information more quickly is welcome to contact any board member for an update.

Vet Cancer Registry

You can search data by breed, age.....
How many? How often? What's best? How are other veterinarians handling these cancers?

For example, I placed skeletal - dog in the cancer database search and came up with: Total number of dogs on file: 6374.

That could be some hefty reading, but if you need answers and treatment options, it could be a life saver.

Addressing the veterinarians that are encouraged to use this site: "The choices aren't simple and they aren't easy, but with better information handling and cooperation among peers, we can improve our ability to choose.

For clinicians, the ability to search thousands of cancer cases, exploring trends in presentations, treatments and outcomes can yield basic and substantive results, which will impact our patient care. We are now able to add our experiences in the treatment of our own cancer patients to veterinary medicine's general knowledge. We in
clinical research, both as researchers and as editors/reviewers, have accepted a standard in which 20-30 cases per report is commonplace. We all recognize how this situation has undermined the value of our literature. This is useful information, but not sufficient to recognize true epidemiologic trends. Only by collaborating and pooling our data can we break through this barrier, spot trends in occurrence and recognize treatments that will set the stage for success and further inquiry. The Vet Cancer Registry has taken a giant leap forward with a free, user-friendly service that enables clinicians to look at the trends established by thousands of cases and encourage research colleagues to share information."

JACK'S BIG ADVENTURE...<br>By Tim and Sally Eller Ovid, New York

Jack and Nellie were finally able to range ahead in the woods as we walked, after days and days of on-lead walking as we traveled coast to coast. We were in the Sawtooth Mountains of Idaho, in the Lowman National Forest, along an old logging road about 10 miles from the nearest paved road. We had only gone about one mile when I noticed that both dogs had gone ahead a little too far, so whistled them in. Nellie showed right up, but Jack didn't. Jack is four, and typically a very calm and reliable standard poodle, unlike his somewhat wilder two year old kennel mate Nellie. Ths time Nellie was right there, but no Jack.

So we called, and whistled...and called and whistled. It was about noon, so lots of time for him get back so we could resume our walk. Jack had never been gone for more than 10 minutes in the past. Further, he was wearing an e-collar, so we started giving him the warning tone, which in the past always had worked immediately.

Still no Jack. ...time for a nick.
Still no Jack. An hour later.
Now what? A little panic starts to set in. OK, Sally will stay close to where we last saw him, and Tim will start ranging out to call him and try to figure out what's up. The country is pretty rugged, and in the 5000 to 6000 ft . altitude range.

A few hunters about, on ATVs, but no one else. We stop those that we see and ask if they've seen a black standard poodle about. They probably chuckle a bit to themselves, but are sympathetic and offer to keep a lookout for Jack. We have NY tags on our car, so right away they are thinking this a city dog, but no...we live in upstate NY, and Jack is in the woods nearly every day. He's trained as a retriever, as well as a therapy dog.

Down to the Ranger Station to report a missing dog. The Forest Service staff is very sympathetic, and will keep an eye out, but haven't heard anything. They warn us that the wolves in area are denning up, and will just kill Jack if he intrudes. The mountain lions in the area more reclusive, so unlikely the problem.

We put up Reward notices on the one public phone; on the road entrance, and where we parked. Tim keeps hiking further and further, trying to make large circles around the last place we saw Jack. Calling and whistling. Lots of lonely miles, but no Jack.

Finally, desperation. We leave a pile of jackets, leads and some prime cheese where we were parked, and give up for the night at dusk. Then Sally takes off for one more check up the trail where he disappeared. Tim waits, and waits, not knowing exactly where Sally was headed, but guessing correctly. So off goes Tim on Sally's likely trail, and finds Sally a mile up the road, near dark. Just too tired and keep going, so we pack it in and head back to the campground to try to get some sleep.

Tim sleeps...exhausted. Sally maybe sleeps some.
At first light, back to the search. Temperature about 20 F . Resolved to try to find Jack's body, having concluded that the only way that loyal, reliable Jack could have failed to respond for so long would be the wolves. Decided the best approach would be start with concentric search circles from where Jack disappeared, hoping to find a collar, or something. Anything.

We drive back to where we had parked, and had left the jackets etc. Both desperately hoping that Jack would be there waiting. But no.

So up the trail to resume the search. Then looking up, there's Jack! On a ledge about 200 ft above
the trail. Not moving, but the bright orange collar unmistakable. Is he OK, or dead? No motion. Up goes Tim, scrambling....and Jack moves! He's at least alive. As Tim makes it up to the ledge, Jack is still not moving but shivering like crazy. He looks OK! Maybe hypothermic...he's not himself, but clearly glad that we finally showed up.

Down we go, more or less head over heels. Jack is dehydrated, but not much worse for the wear. We are worse off, but elated.

All and all, he was gone for twenty hours. We still have absolutely no idea of what happened. He isn't saying. But maybe a few lessons from the experience.

One...trust the dog to find his way back. Searching and calling may have helped, but in the end it was Jack that found his way back. Probably best to just wait...and wait. If the dog is going to get back, it will be because he backtracks himself.

Second, don't give up on him. I'm sure now that he wondered why we left him for so long.

## For the Do-It-Yourselfer:

Portable PVC Exercise Pen

Dog show and agility people have been using metal exercise pens for years. Problem is that the commercial ones are expensive. For about one
half of the price of a commercial, metal exercise pen, you can construct this PVC exercise pen, which ends up being slightly bigger.

Each exercise pen consists of 6 panels. We give instructions for two basic panels: the fishnet panel and the barred panel. The fishnet panels are lighter, cheaper to make and give more complete coverage from prying hands that may want to pet the hounds. The barred panels are sturdier, heavier and easier to keep clean.

## Materials Needed for 6 Fishnet Panels:

- 24 1/2" PVC Ts (not threaded)
- $241 / 2^{\prime \prime}$ PVC elbows (not threaded)
- 11 10-foot sections of $1 / 2^{\prime \prime}$ PVC
o 2436 -inch pieces
o 36 12-inch pieces
- 63 foot x 3 foot sections of fishnet or mesh (or, thin rope to weave into a net)
- Thin rope or cord to attach net to frame
- 25 plastic cable ties (or wire or garbage ties)
- PVC cleaner and glue


## Materials Needed for 6 Barred Panels:

- $841 / 2^{\prime \prime}$ PVC Ts (not threaded)
- $241 / 2^{\prime \prime}$ PVC elbows (not threaded)
- 19 10-foot sections of $1 / 2^{\prime \prime}$ PVC
o 54 36-inch pieces
o 963.5 -inch pieces
- 25 plastic cable ties (or wire or garbage ties)
- PVC cleaner and glue


## Step 1: Shop for Parts

We found the necessary parts at a home store (like Home Depot or Hechingers), but a plumbing supply place may be less expensive. The 10 -foot sections of PVC cost around $\$ 1.30$ each. The Ts and elbows were $\$ 0.15$ - $\$ 0.40$ each. We found the contractor packs of 10 to be one half the price of buying the pieces individually.

For the fishnet panels, we found a 10 -foot by $10-$ foot decorative fishnet at an army surplus store.
 Alternatively, any mesh will work. Heck, you could even macramé or weave your own netting
on the frame with thin rope or cord.

## Step 2: Cut the PVC

Your job will be much easier if all your pieces are exactly the same size. A radial arm saw or power miter saw works great for cutting PVC, especially with a stop-block to ensure all the pieces are the same size. The hand-held PVC cutters also work well, but will be considerably more work.

## Step 3: Dry Fit the Pieces

Construct the PVC panels as shown in the diagrams below to ensure you have all the necessary parts for the 6 panels. We found that attaching the fittings to all of the 36 -inch sections first was best. Then attach the 36 -inch sections into panels using the shorter pieces. Cut extra pieces as necessary. When you're sure you have all the necessary parts, take everything apart again.


## Step 4: Prepare PVC for Gluing

You CANNOT skip this step. You must use the special PVC cleaner to prepare the PVC to take the glue. It comes in a metal can with a brush attached to the lid. IN A WELL-VENTILATED AREA, clean about 1 inch of each end of each piece of PVC. Also clean the inside of each elbow and T .

## Step 5: Glue PVC

PVC glue dries VERY quickly. You have under 20 seconds to position the fitting on the pipe. You won't be able to twist after that, so be certain that your fittings are proper aligned. The safest way we found to proceed was to glue the fittings to the ends of all the 36 -inch sections first, being careful to make sure the fittings on each end pointed the same way. Then go back and glue in the smaller pieces to make each panel.

## Step 6: Fishnet Panels Only

Lay the completed panel over the fishnet and cut to the proper size. Tie a cord to the frame and weave through the edges of the fishnet and over the frame to stretch and attach the net. This can take some time. Be patient with it. Alternatively, tie rope or cord to frame and macramé the netting yourself.

## Step 7: Connect the Panels



Use three plastic cable ties (or wire) to connect each of the panels to the next. Do not make the last connect to complete the circle. This will be your door. Attach a few cords or extra pieces of wire where this last connection would be made so that you will be able to secure the door in the field.

## Step 8: Set Up Your Exercise Pen



Position the panels into a circle. Optionally, use tent stakes to secure the pen into the ground. Or, use sandbags
to secure the pen on a hard surface. Add blankets or pillows as you'd like. Another good idea is to use one of those outdoor canopies or market umbrellas to provide shade for your hounds.

## Enhancements

The following enhancements come from Sylvia Kively of New Hampshire. She attributes them to Kevin Kively.

My husband made an ex-pen using you directions, with a few modifications I thought I'd share with you.

He used CPVC, which is smaller and lighter. To connect the sections, he drilled holes through the pipe and threaded the plastic ties through them to keep them in place. For the door, he inserted eyebolts on both panel ends, and made a rod that fits down through them to secure the door.

## Quick Hound Toys

## Gutless Fleece Toys

It seems like every poodle loves those faux fleece toys. You know, the ones shaped like little people. The first problem with those is that they can cost \$8-\$12 each. Yikes! A yard of faux fleece at a fabric store is around $\$ 8$. With that yard, you can make 10-20 toys, depending upon the shape you choose. The second problem is that the manufacturers put stuffing in them. We have one hound who can remove all stuffing within 30 seconds. What a mess! The poodles have just as much fun with the "gutless" version.

Materials Needed for 10-20 Toys:

- 1 yard of faux fleece (I like the color oatmeal, but any color will work)


## Instructions



For the maximum number of toys per yard and the quickest production time, cut the fleece into $12^{\prime \prime} \times 20^{\prime \prime}$ rectangles. Fold each piece with right sides together and sew as indicated below. Cut between the stitch lines that run diagonally across the piece. Turn right side out and stitch the hole shut.

The poodles are happy with the triangles. However, sometimes you want something special, perhaps as a gift. I've done hearts, initials, bones and gingerbread men. Place two pieces of fleece with right sides together. With a marker or pencil, draw the shape on the wrong side of the fleece (if you're doing initials, be sure the mirror the letter so it will be correct when you turn it inside out. Stitch along the pencil line, leaving a small hole to turn the toy right side out. Turn right side out and stitch the hole closed.

## Toss Balls



Some poodles love chasing after items tossed for them. Here's one that's easy on your throwing arm and a blast for a hound. They take just a few minutes to make and are very inexpensive.

## Materials Needed for 3 Toys:

- 9 feet of rope
- Can of 3 tennis balls


## Instructions



Place one tennis ball in a clamp or vise.

1. Use a drill with a large drill bit to drill a hole through the tennis ball (one hole on each side).
2. Thread the rope through the holes.
3. Tie a simple knot very near the ball.
4. Knot or burn the ends of the rope to prevent fraying.
5. Tie a second knot near the ends of the rope.
